The following information shall be required prior to start of construction/planting/alteration:

- This application must be approved and signed by ACC to be valid,
- Must have a City Building Permit (as/if required)
- Permit must be brought to the District Office before work begins on the home. Property pins on affected side shall be located and displayed by applicant.
- Locate proposed work or addition on a copy of Final Engineering Survey for the home and lot. Show shape, dimensions, location and identity of area(s) where the work will take place. Use the same scale as that shown on the Survey. If proposed work cannot be clearly shown on a Final Engineering Survey, include a scale drawing as previously described. Trees must be removed, stumps must also be removed. Any structure must be set back a minimum of *10 feet* from property line on street side(s) and rear, side setbacks a minimum of *6 feet*. Construction and/or planting are not permitted in easements or setbacks.
- A \$10.00 ACC Application fee shall accompany initial application.

Exterior of appurtenance (Patio, Utility Buildings, etc.) should match siding of the mobile home or blend in architecturally. All accessory structures must be tied down.

All debris must be cleaned up daily and removed upon completion of project. All materials must be stored in the carport.

**Any Construction without an approved ACC Application will be stopped immediately.**
