- 5. Announcements by Chairman - Bud Getz
 - a) Change to order of agenda Interim District Manager's Report# 17 and move to number 4A.
- 4A. District Manager's Report Bob Shearer Status of last 2 weeks of work
 - a) Sound Panels installed in Card and Pool Rooms hopes all will go and check them out. Thanked Patty Peck for the idea of using the panels we had on hand. Estimated cost was \$9,000. Had park crew install, saving the \$9,000. They may not be 100%, but if someone can recover them, that would be great;
 - b) Library lay out changed. Area at end for computers and tables for 4 or 5 people to get together. Still looking for chairs and some end tables. Table in front of window will be set up with electricity for laptops as that is a hot spot. Round table will be kept to be used as a puzzle table. Someone can start a puzzle and leave for others to work on. Encouraged all to check out the room layout;
 - Outside Bathrooms Painting is 90% done, electrical and ceiling is complete, floor and wall tile are at 50%. Bob pushing as hard as he can for a 12/31 complete date. However, washers and dryers may not be brought in until 1/2/17. We would need to pay for the entire month of Dec - so we will wait until January and begin payments at that time. They will be the same ones we had, but will be upgraded to handicap as soon as they get some in. They are on back order;
 - d) Gatehouse new heater/air conditioner purchased for \$499, staying under the \$500 that needs board approval. Old one went bad;

e) New position created calling it the Utility Person. Upon reviewing the Custodian work schedules, one large cost was overtime. We have 3 and when one went on vacation or was out sick, another one picked up the time and that person was paid overtime. A week's worth of overtime was killing us. Bob has tapped Chris of the Grounds Crew to fill this position. As most know Chris was a Custodian at one time. He will still work on the Grounds Crew but when we have vacations or someone is sick, Chris will fill in, starting on 12/15. He will work nights or weekends. I think it is great that he is giving up a 5 day a week job, all days. By the end of the year we should see a significant cost savings in this park in the overtime we were paying out;

f) An ad has been placed for District Manager. There are around 30 applications in the office already. We will be going through the separation of those and Bud will be discussing how we are going to handle that a little later on. Manpower was here at the last meeting. We were not signing with Manpower. They asked me if they could find us a manager and I did not say no to them, nor did I say they had an all exclusive to be the only person. If they bring us the right person, we may have to pay a commission or if another agency wants to bring someone in, I don't care. However I think we are having a lot of luck with everything we are doing on the

outside;

- g) We are working on the liens. Liens have a minimum of 5 yrs question is whether the 5 yrs is permanent and I have been working with 2 different people and I get 2 different answers. Every lien that was in place is still in place and we will move forward from that. I have asked Bruce Crabb to get involved with me and we will begin in Jan. We will go to the tax assessor and see what we can do about these properties that are currently owing a ton of money and we will never get the money back from them. We need to get a forgiveness. I spoke with Palm Bay and they are all for this because they want to get them back on the tax rolls. It may take until March because we will not have an answer in one week. That is our status on liens. We are working on them. We did pass Resolution 2015-03 and I want people to know that is says the park has the right to fine anyone in the park up to \$250 a day if you are in violation. That was passed in April of 2015. So it is already on the record books and we will be placing liens if we need to. Hopefully that is something we will not have to do;

questioned if the resolution was legal because the copy she has is not signed. Traci stated the document is e-signed on the computer - but signature did not print on copies;

- i) Bonus situation for employees Bob would like it placed on the agenda tonight, It has been brought to my attention we cannot give a bonus or a gift without taxing it. I am proposing that we give anyone in a supervisory position, and I have 4 of those, \$55 and take home \$48 \$50 and the rest on the employees, 16 people, \$30 and they would take home a little more than \$25 after taxes. It would be a total of \$720. In my opinion this is just a thank you for what everybody has done this year to keep this park going. QUESTION FROM TRUSTEE: what employees does this include. Bob every employee including every gate keeper. COMMENT FROM TRUSTEE Cathi we can ask the payroll company to gross up the check so that the bonus check received would be exactly \$50 or \$25. COMMENT Bud Getz we will add this to agenda as 13A.
 - Solid Waste Services sent a letter to the office. The specifically say we can use no plastic for leaves and brush because plastic is not recyclable. All will need to invest in a plastic container for brush. They did say if you use plastic bags, open them up so the guys can grab hold of it and empty into truck. They will leave the plastic bag there.
 - k) Swimming pool this is the big one hang on to your chairs. A lot of money has been put into this building. Our swimming pools, from what I can find, have been there forever. We made a mistake a few years ago and took a building out, put another band aid on it and did some work. There are big white boxes at the end of the pools all the water comes into those boxes and goes through filters. The filters are no good. They are worn out so bad that the water just goes though the box and the dirt goes right back into the pool. The motor housing are so rusty that they are ruining the water. We just put in our last pump. We were shut down for a few days and that pump went bad within 4 hours of it being installed. The water line going from the cold pool over to the white box has a major leak in it. Go to the cold pool and you will see where the concrete has sunk down at least 2 inches. That is only going to get worse because as the water runs underground it washes away the sand and we are looking at the possibility of one of those pools collapsing. I am giving you the worst case scenarios. These are estimates - not a formal quote. This company is coming in on Weds to give a quote

- l) Suggest doing cold pool in Feb-March and bandage hot pool until Jul-Aug and do the hot pool at that time. This is something the Board needs to think about and decide what to do. I will bring quotes to Jan meeting. COMMENT FROM BOARD Marilyn Will this take care of the drains in the bottom of the pool? I was told that was causing the staining. BOB It will be fixed because we are going to fix the white boxes and replace the copper pipes with plastic. It is not going to get any better and there is no better fix out there than this one.
- m) Closing remarks would like to go over 3 things
 - 1) Change orders When doing large projects and we are in the middle of the project change orders will happen. When you take down walls, open things up, change things around, you will get change orders. You cannot take that out to bid with a different contractor. It would be a nightmare. Take your kitchen as a prime example. If your wife said I want 10' of cabinets and after you get in the job and realize you have room for 13' of cabinets, you don't go to another cabinet maker to make the 3' of cabinets. You have to trust whoever is up here to make a decision. If you cannot come up with and answer between the contractor and the owner, the architect is paid to be the mediator. Our last change order in here, if anyone wants to check it out, we paid \$3200 to ceramic laundry room. That guy got beat up bad. tile 2 bathrooms and a was a \$10,000 job He can't even buy the tile for that. It 2) This one is a big one. All I have heard is how much we lost with the Jody deal. I've done my math. We were under a deal to pay Jody 3 months probation @ \$5,000 a month. He only worked for us for 2 months and he would have been obligated to be paid for 3 under the 3 saved \$5,000. The next month probation. So, right off the bat we

thing, we are not paying anyone in Dec. or Jan. It will be at least Feb before we get anyone in here. That is another \$10,000, making it \$15,000 saving we are up to. Now let's talk about this park ran with 2 full time people. We have not had that second person in the office since the end of August. That is \$9,800 with insurance, taxes and benefits that we saved. That is a total of \$24,800 and that was saved by the 9 people. I am tired of people getting on them because each one of them came up here and worked mornings and afternoons. Now they are still working afternoons. Guys they are not getting paid. So they are the ones that have save you this \$24,800. So when you get a chance, how about taking the time one by one to say "Thank you for a good job and we appreciate it."

I'm going to end with this one. I'm going to ask, if you have problem or you have a question or you are not happy with something, how about you follow the chain of command. I have people come in my office everyday. I have not closed my door to one person in the one month that I have been here. Everybody can testify to that. If you have a problem and you don't think something is right, rather than take up 3 hours of our time at one of these meetings, come in, deal with me and let me see if I can figure out a solution. If I can't figure out a solution or it's one that you don't think is right, than you bring it here. This is how we should be handling it. So I am urging everybody to use that avenue first. My door will be open. I will give can get and Jean has been there, everyone the most honest answer I answer for them. COMMENT - BUD GETZ- "I want to thank Bob for all that he has done. I think if we were to hire a District manager today, he would be the guy because I would put a chain on his ankle. But I don't think he will go along with that.

COMMENT- CHUCK ROAN - 220 Borel Circle - I'll tell you how to save some money also. You know we are paying a dollar a week for this man. I think we should cut his pay in half and save that money. But I think he is doing a great job.

- 5. (Cont.) Announcements by Chairman BUD GETZ
 - a) Inline with what Bob has said about the costs, I want to tell you what we

and how far we have paid so far for the project for the whole building have gotten into the outside restrooms as of today. So far we have paid \$163,004. Now I am being asked by the contractor for \$8,000 more because he went and bought all the supplies to finish the bathrooms and he still wants another \$1,600 and then he wants his final payment of \$19,600, which he will not get until we are 110% satisfied with the job. So tomorrow, Bob, I would like you to find out about the \$8,000 because I am not even going to ask for approval tonight. I think we are to the point where having \$163,000, he should be able to finish. So, if you can do that. When we finish with the \$19,600 and the other \$1,600 for the tiles for the restrooms out here, we will be up to \$184,264 for all of these improvements. I think when we originally had the 3 quotes come in we were in the \$148,000 area or somewhere around there. By not keeping track of the District Manager and allowing someone to sign contracts on behalf of the Board without review has cost us all these extra funds. We have just finished revising the District Manager's job description and we will take that up at the first meeting in January and we will use the new job description for hiring the new District Manager and the controls on monies will be much stricter than the no control that there is today. That is a promise.

- b) A gentleman came in today from Borel Circle and he has his car parked on the lawn. Someone has been complaining about the car parked out there. His explanation was his carport was severely damaged during Hurricane Mathew. He has a signed contract with Palm Bay Aluminum to have it repaired. He is afraid that if he parks his car there and we get a high wind that it will drop on his car. I told him to leave his car on the lawn. If he doesn't get it done in another month, we will begin looking at Palm Bay Alum. COMMENT COULD NOT BE HEARD SPEAKER DID NOT COME UP TO THE MICROPHONE.
- c) I received a note from John B, gentleman responsible for channel 732. He asked that all of the trustees go through the Chairman of the Board for any changes they want to make to 732 so that he gets all the information from one place instead of 9 places. That will begin right away. COMMENT COULD NOT BE HEARD SPEAKER DID NOT COME TO THE MICROPHONE.
- d) I just received a resignation tonight from Cathi, who is the liaison between the BOT and the ACC. That liaison has to attend every ACC meeting

- because the ACC reports to the BOT. The HPPOA reports to you and no one else. I will need a volunteer to attend the ACC meeting and they have one tomorrow. Whoever is going to volunteer needs to be there tomorrow.
- e) Allison Kelly is being appointed to lead the search for a new DM. She has a lot of experience in that. We have 15-20 applications right now. Allison will bet a couple of residents from the park to form a committee to go through these. She will tell you what to be looking for and try to pair this down and see if there are any good candidates within those applications. At that time she will bring that information back to the Trustees.
- f) I was asked if we still had a fishing club. If we do, please let someone on the HPPOA know, so that they can post that we have it.
- we received 2 letters from a gentleman claiming to represent a large number of people in the park. I want you to know this right now I have not named anyone. One of his complaints was about what we did concerning the prayer meetings or the church meetings that were being held in the hall. He said we were going against people's right of freedom of speech. At the meeting that we made the determination not to do that, the vote came from out here. The vote did not come from up here and the vote was within the guidelines of "if you do it for one, you have to do it for all". That is why the decision was made the way it was and we are not going to tackle it again.
- h) Today, we had another gentleman who came up with another Florida Statue that said in any mobile home park any of the residents can get together in a group, as long as they are not causing problems and they can come in the hall and do anything they want under this Florida Statute. Immediately I sent this to the attorney. I haven't talked to the attorney in over a month and this week I have been on the phone until 9:30 almost everyday. I sent him the information of the Statue, and he came back and said "Chapter 723 does not apply to Holiday Park. You can regulate the use of the facilities without any conflict with 723", which is the statue this person brought in. So, this discussion is dead. We are not going through it again. We are following the laws that we were supposed to and, believe me, I run it all through the attorney first.
 - i) Now back to the items we have. We have 10 items on this one page, and while I would like to read all of them to you, but I am only going to address one.
 - j) I was accused of singling out an individual in the park at the last meeting

I am finished with this crap. COMMENT -KEITH R. - I agree about not being vocal about it, but there is nothing wrong with turning in somebody who is going through cigarette butts out here, but do it nicely. Tell the office. If you see some unwanted activity in the park, come and fill it out, but please do it nicely, as Bob says. We do need to know and, as citizens, we need to take care of that. Please, do not expect a lot of jumping up and down - just let us know so we can do our job the best we can. Just don't jump on us or any other people. Just give us as much information as you can. Thank you.

 - Keith some of budget items were over 25% and 50% on some items and I would like a little explanation. Storm Water Management, page 2. Cathi - I don't know what SWM is. Bob will investigate. Marilyn suggested it might be a quarterly payment. Cathi agreed it may be quarterly payment. Next one is page 3, 76% on R&M Building. We spent \$3,000 of the \$4,000. No answer available. The other one is supplies and recreational at 113%. No answer available. Bob suggests bringing these into the office and he will get answers for him. Keith agreed.
 - ii. Marilyn and Rod mentioned the R&M costs may be the 2 pool pumps that we went through in Nov.

 - b) Bud asked for a motion to approve POP as written
 - c) Allison "purchases by the manager under \$500 requires Trustee approval." Should that read "over \$500? Jean answered should say "over" - will change
 - d) Marilyn states "maximum amount to be spent each month is \$500". We do need to put a limit, but \$500 isn't even one pool pump. I think we have to give a little flexibility. Jean said there is an emergency clause to be approved by chairman. Marilyn feels \$500 is to low, however it does need to be limited.
 - e) Bob Line 1 reads, regardless of purchase, all purchases must be approved

Florida Leak Proposal - Bud asked Bob to explain 11.

- a) Bob this is another item that needs to be tabled. We would be going out and spending \$1,200 on their proposal to fix a leak into the cold pool. There is no sense in tearing out bricks and concrete to fix the leak and then some time in Jan or Feb we turn around and tear it all out again to do the major repairs. It would be an easier fix to do that all at one time. The worse case scenario - and I will check with Jose - but maybe we should shut down the cold pool in Jan, so we don't have any more problems. I am meeting with these people on Weds and we will look for our best cost solution to keep this thing moving.
- b) Keith made motion to table 2nd by Rod
- c) Bud call for vote approved
- d) Bud If you want to see what Bob is talking about, walk to that end of the warm pool and you look at all the pavers, they are all level. As you walk towards the cold pool they start going downhill and there is a gap about this high when you get to the middle of them. Look on the pavers that are out there, one of them has an X painted on it. That is where they found the leak underground. In order to fix that, they need to take out all those pavers, all the stone, break up the concrete and remove it and fix the problem. It is sinking because of the magnitude of the leak. This all comes back to what Bob said in his report about the \$80,000 to fix the 2 pools. I don't think any of these items have been taken care of in the past and the pools are 30 some years. We will have to bite the bullet and we will have to have this done if you want to keep swimming. The day we turned to pumps off, there was H--- to pay in the office because no one wanted to go in the cold pool and everyone said why don't you get I fixed. We are at the mercy of the people who put the pumps in and we think the pump is good. But as a rebuilt, it lasts a couple of days and then it is gone again. There is something wrong with the system and if it is not pumping water, it does not keep the chemical activity going the way it is supposed to. You do not want to get in that pool.

i. Jean Beach, 1090 Moonlight Court - I know we have new mikes, but when you are speaking, particularly you ladies, please put that mike up to your mouth. It is extremely difficult to hear people on this recording. We really cannot hear people. We cannot hear the recording. We are sitting back there and we cannot hear who is seconded those motions. COMMENT - BUD - The other day we had Jose set up the microphones after the fiasco we had at the last meeting. He set up all the controls and he was holding the mike over a foot away and we could hear him out in the hallway. So, he left everything set the way it was and when we came in here tonight and tried it, you could not hear it anymore if you moved slightly away from the mike. So, we have to find a way that once we set these mikes up for this room, that people

Seany set them up and when we came in tonight, they aren't working right. Bud asked Rod to check on the problem.

- ii. Ginny Getz, 1142 Keystone I know our old house had rats in it and they were down the street when the house was empty, near the wolf house and other people have had them. Alpine Tree Service said that rats live in nests in the palm trees if you don't cut them back. I don't know the answer any more than anybody else, but just getting them out of this building, the guardhouse and the compound still leaves a whole lot of the park that has rats in it. Can't we do something? The feral cats have got to go and that is a big part of the problem. I understand there is someone feeding the cats and the raccoons up behind Ziggys. COMMENTS - BUD - I think we can ask Bob to ask the contractor when he comes in on his ideas on how to rid the park of rats. I don't think we will come up with an idea that is actually going to work. GINNY - maybe not, but we need to do something to get rid of some of them. BUD - we will look into what we can get the rodent control to suggest. BOB - I don't think it is Ziggy's. I have seen people go back there and feed the cats and raccoons. MARILYN - We have people in the park who feed the cats, the raccoons help themselves and then the rats are there. We have to talk to our neighbors and encourage them not to feed the cats.
- 13. Storage Compound regarding the number of vehicles you can have in there
 - a) Last meeting we presented a change to the document about one vehicle to one resident and that was it. People took exception to the way it was written. So, once again, I spent our money on the attorney. The attorney sent it back and it reads this will go at the top of the particular district regulation relative to the storage compound "Usage of the Vehicle Compound Storage Space is not an entitlement but is a privilege allowed to the property owner/renter, hereafter referred to as a "resident" by the district by a space available basis. It was always been an unwritten rule that the space available clause was restricted to one space per resident

All of the Trustees have had the opportunity to read that so I would like to have a motion that this is the amendment that we make to the Park Compound Storage rules.

But, in the meantime They are still part of the Board. So, we have 2 to replace and we have 5 people who have applied. I need to know how we are going to go with the vote. Keith they need to be replaced in Jan, right? The Board will finish filling out this term, right?
 - d) Bud yes. Let me back up. The elections are in November. At the time of the elections, the BOT is supposed to have and election for the positions available on the Board.
 - e) Barbara Kirsch, 349 HPB When I ran for election, we had many people running back when we ran with Ronald Reagan. I think that is the one and only time that has happened, that I can recall.
 - f) Bud -That still does not solve the problem with the 5 people and the 2 positions. It is almost to the point where we have to take a vote.
 - g) Cathi when I was appointed, there were 2 positions and there were 4 of us. We had a short interview and then the Board made their selections and appointed 2 of us.
 - h) Bud -We have 5 resumes to read and you read those. So, out of the five people, 2 people will be appointed at the Jan 3 meeting, just prior to the reorganization of the Board and I can find numerous occurrences in prior minutes where individuals were appointed to the Board just as I and Allison were appointed earlier in the year. election in the state of Florida, meaning that anyone who had served 6 or more continuous years could not go on for another single term of 2 years. So, Becky's terms, when she resigned, she stated she had 10 years of service on the Board. So, I went back through all the records to check, and I went back as far as 2008, and they were continuous services up to there and I stopped at 2008, because we were already well over the 6 years.

- k) Bruce Crabb, 442 Neighborly Court If I remember the discussion, when you passed the amendment on the term limits, I distinctly remember that is was 3 elected terms to the Board, not appointed, and Becky was appointed several times to fill vacancies. So, my understanding of what was voted, was 3 elected terms where you file your papers and are put on the ballot. It's only in recent years that we haven't had people elected. We used to have 4 or 5 people running for Board seats and we would have a little gathering here in the clubhouse and have coffee and donuts and everybody could shake hands. That is the way I remember that proposal, as 3 elected terms.
- 1) Keith I would like to meet these people. I do not know most of them, so before I vote, I'd like to meet them so I guess I would want to table this until I meet them.
- m) Bud -We are not going to table it. If they are here tonight, you can meet them tonight. If they are not here, that is not our problem.
- n) John Lalima, 1055 Sunflower The way it was done in the past. When there were more that 1 person to fill a vacancy and those people had a right to speak. Each one could be nominated for the position by a member of the Board, 2nd, and then a vote was take to accept the person or not. You don't just vote on each one. A Board member must nominate the person for that position.
- o) Marilyn can I ask how many we have here tonight?
- p) Bud the five people are Sal Cursey, Carole Helton, Kendra Bender, Joe

- r) Becky Earnst, 205 Borel Circle I made the application to become a Trustee and I was told by the Supervisor of Elections that because I paid the fee and that was done before the term limits were put in and just because there was no election in November, I was already elected.
- Bud The Supervisor of Elections told you that because they don't know what the rules were in the park. This was all taken up with the attorney before this meeting. We have on file, a term limit case that was filed in the State of Florida, concerning the same situation. It was the case of Levy vs Woods, City of Palm Beach Gardens. They adopted a term limit resolution, which included language stating "service in a term of office which commenced prior to the effective date of any term limit enacted, will be credited against any term limitation approved." In that case, the eligibility of the winning candidate was challenged based on the term limits set. The new term limits were 2 consecutive full terms and the winning candidate served 4 prior terms. Levy convinced the trial court that only the term limit that immediately preceding the new election was to be credited. Woods appealed and the Appellate Court stated that "all prior terms need to be credited and declared Levy ineligible. So, by implication, this case suggests that retroactive term limits were not improper and that was done in Palm Beach Gardens. According to our attorney, it's effective here.
- t) Becky But is doesn't state that the person had already gone through the process and applied as everyone should have to get the position the way I have.
- u) Bud It says retro-active and when you go to the person you registered with for the election, all they knew was that there was no one running for the position against you and they did not know that there would be term limits to be faced.
- v) Becky How are they going to know that? At the time of the application, they do not know that.
- w) Bud Do you think the people in this case knew that?
- x) Becky You don't know. I also called the General Council for the State of Florida this afternoon and asked the same question. I have not heard back from them. According to the Supervisor of elections, once elected, you

Keith made a motion not to approve the proposed bylaw addition. Motion 2nd by Molly Stone. Discussion followed. Molly stated that the present version had differed greatly from other versions, and we were Version #6 to get the terminology correct and the legality of the issue. She also stated that when a person is appointed to complete another person's term that is less than 2 yrs, it should not be counted as a full term limit in the calculation of the maximum 3 term limits. That was her personal opinion. That is not written anywhere in the law. Keith stated that the term limits restricts people who may want to come on the Board. I think it opens it up to people who want to come on the Board. Bruce Crabb presented a proposal consisting of 3 sentences which would cover term limits. We did not accept that and I know what they were anymore. Bud Getz advised that bylaw changes need legalese, in case charges are brought against the Board. Charlotte Gladston stated that she had put in for a Trustee position and we should have term limits. John LaLima asked if the term limits had been approved by the attorney. Bud Getz advised that the attorney wrote them, 6 versions of them to get them down to where we needed it. The vote was called for the motion not to approve adding term limits to the bylaws. The motion was defeated with 3 Trustees voting yes and 5 voting no. Marilyn made a motion to change the bylaws and add term limits as stated in Version 6. Phil 2nd - no trustee or public comments were made. The motion passed 5 voting yes and 3 voting no and that is where it stood.

No person shall be elected or appointed to the position of a Trustee for more than 3 consecutive terms. For purposes herein the term of office shall be that which is defined by section 418.02, the Florida Statutes

and may be amended, which is currently 2 years. However, that service in less that a full term, shall be considered a term of office for the purposes herein. Service in a term of office or part of a term of office, which commenced prior to the effective date of this sub section will be considered in the calculation of term limits set herein. Only those prior terms or parts of terms which were consecutive with each other would be consecutive with the new term and shall be used in the calculation. No person who has served 3 consecutive terms prior to the effective date of this sub-section shall be eligible to serve as a Trustee. But, any sitting Trustee who otherwise, meet the term limits shall be allowed to complete their current term.

- ii. Interrupted could not hear from audience Bud She is currently not on the Board. You were not elected we never made it to November how could you be elected when November is the month in which elections take place. You filed for re-election.
- iii. Continuing on, By way of further explanation, if a Trustee was elected or appointed to a term, part of a term or terms prior to the effective date of this sub-section, whose terms will be used in the calculation of the 3 term limitations, as long as they were consecutive terms and if the total of those prior terms equals or exceeds 3 term limits now imposed, then that person shall not be eligible to be elected or appointed as a Trustee, provided, however, even if the prior elected terms equaled to or exceeded 3 terms. The Trustee shall be entitled to complete their current term, if they were already in the term.
- iv. Had Becky not resigned on her own, she would be right now in her current term, which still would have taken it over 6 years.
- v. Continuing on Furthermore, any person who has left office prior to the expiration of the term shall not be elected or appointed to an office if the term of the office sought including the prior terms would exceed 3 consecutive terms. By way of further explanation, if a trustee was elected to a 3rd term, but left office before completing the 3rd term, they would be ineligible to be elected or appointed to a new term, if the total of the new term and the old terms of office would exceed 3 terms. Not withstanding any of the above limitations, a person may be elected or appointed to an office if they sit out for a full term. Not withstanding, the provisions of Sections 1 and 2 of the BOT, by a super majority vote (6), may waive the restrictions on appointing a member to the BOT, if it

is determined there are no other persons willing to serve in the appointed position, except a person or persons who would otherwise be ineligible due to the term limitations herein. Subject to the provisions of A. above, if the office of any member of the BOT becomes vacant prior to the expiration of such member's term of office, the BOT shall fill the vacancy by majority vote of the remaining Trustees, by appointment of a successor from among the electors in the district. Such appointed member shall hold office for the remainder of the term of the vacant office, (which is what the 2 of us right here are doing). In the event that any of the elections shall fail to fill a seat of a Trustee, the BOT shall fill the seat by appointment of a successor by a majority vote of the remaining Trustees from among the electors of the district. Such appointed member shall hold office for the remainder of the term of office. For purposed, herein, elected term election shall include both contested and uncontested candidacies for position on the BOT.

- vi. The amendment to Article 6 was approved by a majority vote of the BOT. The remaining provisions of the by-laws dated March 13, 2006, and any previous amendments thereto, unless modified herein, shall remain in full force and effect. (That is the end of it)
- a) Comment from public could not be heard
- b)Bud -I'm sorry we gave you 6 versions of this and we voted on Version 6.

 Molly objected because, it went back to, whoever knows when. It took 6 revisions, with the attorney, to get the wording to where it was acceptable to the general population of this park. That is what we passed. It stands that Becky is ineligible to serve, whether the Board of Elections told her she was automatically elected or not. If she needs to take it up with the Board of Elections, so be it.
