5. Announcements by Chairman

- 1. No office documents are to be sent to non-residents by board members.
- 2. In case of an emergency, dial 911 FIRST. Do not call the office. It is not a health facility.
- 3. No homeless visitors are allowed in the park at any time. Gentleman living with his sister brought in someone wanted by the police for breaking and entering.
- 4. Calling the District's attorney for park documents is very costly to the park. All document requests should go through the park office directly.
- 5. Attorney received an unsigned request for documents regarding a motor home, boat, F150 truck, credit cards, etc. Anonymous complaints to the attorney will not be addressed.
- 6. Sharon Johnson was released. It was discussed with the park attorney and we won't go into what that info is. Park attorney was in agreement. As a reminder, the office is closed to everyone except current trustees. All business should be conducted at the window. Please keep your presence at a minimum; since we are down to one person.
- 7. After a storm park maintenance is responsible for public areas only, not owners' property. Park maintenance is only responsible for private property to the extent of lawn mowing, weed trimming and edging. Fronds on private property are the responsibility of the resident.
- 8. Per District's Deed Restrictions, no signs are permitted on lots, except real estate signs or political signs in window, planter box or as approved by the District Manager. Political signs may only be displayed beginning four(4) weeks prior to an election and only total of four(4) square feet to be removed no later than twenty-four (24) hours after the election.

Jody Storozuk noted rumors that he was fired brought everyone out tonight. I make mistakes. Sorry if you don't like it, 10 people might like it. Threshold is less than 1% is for sale in the park. [Probably referring to units for sale]. I had a conversation with a responsible woman. Property values are raised. Lot of people don't like change. People think I'm stealing. If you think so, don't listen to rumors. I have a woman making curtains. I'm doing the best I can. Come see me if you have questions. I make mistakes. Don't accuse me if you don't know the story. Concrete ditches need work. All the crew doing best they can. Pool room will be ready the end of the week then bathrooms outside started. I'm working as fast as I can getting work done. Chuck Roan, 220 Borel, interesting what's been done.

Phil Matton said, what galls him is people calling him a traitor. He needs a list of who can call the Board's attorney.

Rod Lindsay reiterated, trustees can't talk to trustees, so we can't get it done instantly, we can't discuss things before a meeting.

Molly Stone thanked residents for coming and sharing, saying new ideas and old ones are good. She reiterated the edict in May that there is no one in the office but trustees and the girls, as it interferes with their work. She was in the office on August 29, Bruce Crabb was in the outer office with Jody and Traci, definitely interfering with the one person in the office.

Marilyn Spall thanked everyone for coming.

Cathi Brennan thanked everyone for coming and participating.

Bud Getz, Chairman, asked Jody to go to the other end of the building. So we can discuss park business. Bud said this is the most difficult meeting we have had in the park for trustees who represent everyone here. There have been complaints about the District Manager [Jody Storozuk] on several subjects. There have been charges against accounts run by the District Manager and fraudulent claims. There is over \$1,000 that he wrote a check to repay. Our Attorney advised that paying off something fraudulent charges doesn't excuse it. Sandy [Brown, Accountant] has traced receipts. Her work used to take 3 hours, but now takes her 6 hours.

Questionable receipts are for fuel up I-95 where Jody lives. Bud asked the ladies [accountant and treasurer and assistant treasurer] to go through receipts and credit card receipts and they found fraudulent and other receipts in addition to fuel.

We have been asking for the certificate for the course. On 6/17 he went for a course on grant writing north of here. [Rhode Island] Bud continued, he has been asking for the certificate and has not gotten it. Jody was married and was gone all week. We have to assume he was on his honeymoon.

Jody gets one week's vacation after 6 months, this was after 3 months, and he takes a lot extra days off.

We are losing people off the park maintenance group, causing problems of maintenance of the grounds. One problem is rain.

Our Attorney suggested that we have special meeting to decide whether to keep or release or charge him. From now to Wednesday he is not allowed in the park. There will be an emergency meeting Wednesday at 10:00 am.

Dan O'connell, 286 Borel, stated, this has been going on for months and some board member told you about this. People have suffered. Some people were worked over because they told the truth. Bud Getz replied, everything we do needs to be done here according to the attorney. It takes the whole board to fire him. Sunshine law says we meet now and here. It is how we have to go about this in the park. If we don't follow rules we are subject to breaking the laws of the state of Florida. It's the law, 24 hours' notice for an emergency meeting.

Becky Earnest, 205 Borel, asked for his resignation and documentation. Bud replied, he will ask for his resignation. Bud continued, it will be on the agenda for Wednesday 10:00 am. If he doesn't resign, he can defend himself. Bud asked the audience their opinion for keeping him, no response, and for dismissal it was unanimous.
