**5. Business: Sidewalks** – Chairman referred introduction of contractors to Terry Steimer, who reported that the contractors were invited here to present their company's proposal and answer any questions or concerns.

**a.) Introduction of DFI representatives:** Daniel Vital and Casey.

This company reported that they can begin the project as soon as possible.

**b.) Introduction of Doug's Concrete representatives:** Doug Frasier and Chris Pinson, General Manager.

This company reported that they can begin the project on June 25, 2021.

**Both companies recommend:**

- 6", 4000 psi with commercial fiber
- Slope will be maintained as currently in place
- One year warranty
- Wash out is done daily and removed from premises at the end of the job
- Cones/caution tape will be placed at sidewalk ends
- Tree roots will be cut out under concrete only
- Traffic will be monitored – safety is important

Comments seem to favor Doug's Concrete as this company has previously completed sidewalks in the park and folks seem to like the work. The proposed bid is less money. 6" should be considered for approval vs. the 4".

**8. Action:** Motion to award sidewalk contract to Doug's Concrete, choosing 6" thick, 4000 psi with commercial fiber option at the proposed bid price of \$367,350.
